DECISION

Regarding the approval of changes to the registration for trading of An Binh Commercial Joint Stock Bank shares.

GENERAL DIRECTOR OF HANOI STOCK EXCHANGE

Pursuant to the Decision No. 01/QD-HDTV dated June 30, 2021 of the Board of Members of the Vietnam Stock Exchange on the establishment of the Hanoi Stock Exchange;

Pursuant to the Charter on Organization and Operation of the Hanoi Stock Exchange issued by Decision No. 08/QD-HDTV dated July 9, 2021 of the Board of Members of the Vietnam Stock Exchange;

Pursuant to the Law on Securities No. 54/2019/QH14, as amended and supplemented by Law No. 56/2024/QH15;

Pursuant to the Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/ND-CP;

Pursuant to the Regulation on Registration and Management of Unlisted Securities Transactions issued by Decision No. 23/QD-HDTV dated March 18, 2026 of the Board of Members of the Vietnam Stock Exchange;

Considering the application for change to the registration for share trading of An Binh Commercial Joint Stock Bank;

As requested by the Director of the Listing Management Division.

DECIDES:

Article 1. To approve changes to the registration for trading of An Binh Commercial Joint Stock Bank shares with the following contents:

- Stock name: An Binh Commercial Joint Stock Bank shares;
- Type of stock: Common share;

- Stock code: ABB;
- Par value: 10,000 VND/share;
- Form of issuance: Public offering of shares and issuance of shares under an employee stock ownership plan;
- Number of additional shares registered for trading: 362,171,923 shares (Three hundred sixty-two million one hundred seventy-one thousand nine hundred twenty-three shares);
- Value of additional shares registered for trading (at par value): VND 3,621,719,230,000 (*Three thousand six hundred twenty-one billion seven hundred nineteen million two hundred thirty thousand dong*);
- Total number of shares registered for trading: 1,397,208,685 shares (*One billion three hundred ninety-seven million two hundred eight thousand six hundred eighty-five shares*);
- Total value of shares registered for trading (at par value): VND 13,972,086,850,000 (*Thirteen thousand nine hundred seventy-two billion eighty-six million eight hundred fifty thousand dong*).

Article 2. An Binh Commercial Joint Stock Bank is obligated to disclose information in accordance with current regulations and comply with the provisions of the law on securities trading activities.

Article 3. This Decision takes effect from June 3, 2026. The Director of the Listing Management Division and An Binh Commercial Joint Stock Bank are responsible for implementing this Decision./.
